

At the invitation of Mr. William H. Harrison the following gentlemen met at Hotel Latham in the city of Hopkinsville, on Friday night, April 18th, 1902, for the purpose of organizing a literary society, Messrs ~~W.H.~~ William H. Harrison, Edmund Harrison, Clifton Long, T.C. Underwood, E.B. Bassett, Ira L. Smith, and John Stites, and Drs. Manning Brown and F. M. Stites.

At the conclusion of refreshments the house was called to order, and the object of the meeting stated by Mr. William Harrison, whereupon Mr. William Harrison was chosen Temporary <sup>Chairman</sup> ~~President~~, and John Stites Temporary Secretary upon the motion of Mr. Bassett.

Dr. F.M. Stites moved that the society proceed to adopt a name, said name to be selected, provided it met with the unanimous consent of the society- Mr. Clifton Long seconded the motion, and it unanimously carried.

On the motion of Mr. Bassett seconded by Mr. Smith the members proceeded to suggest names and vote on same.

THE REVIEWERS; THE QUERY CLUB; and THE LITERARY AND SCIENTIFIC CLUB were suggested, but as unanimous consent could not be obtained, after much discussion, upon the motion of Mr. Bassett, seconded by Mr. Underwood the selection of a name was postponed until Monday afternoon, April

21st, 1902, at 4 o'clock, at which time a committee composed of all gentlemen present should meet at the office of Dr. F. M. Stites' for the purpose of selecting a name and adopting suitable by-laws.

On the motion of Mr. Edmund Harrison, seconded by Mr. Smith the following offices were created for the society- A President; Vice President; and Secretary- Treasurer.

The election of permanent officers was then taken up, and on the motion of Dr. Stites, seconded by Mr. Bassett Mr. William Harrison was nominated for president and there being no other nominations he was unanimously chosen.

Mr. Jhos Underwood was nominated for the office of Vice President by Dr. Stites; and Dr. F. ~~W~~ Stites was nominated for Vice President by Mr. Bassett, the nomination of Dr. Stites was withdrawn, and Mr, Underwood was unanimously chosen.

John Stites was nominated for Secretary-Treasurer by Mr. E. B. Bassett, and there being no further nominations he was elected to the office.

On the motion of Mr. Edmund Harrison, seconded by Mr. Underwood the officers of the society were selected as the programme committee for the ensuing three

*Upon the motion of Mr. Underwood seconded by Mr. Stites it was agreed that the society should meet on the first Thursday in each month.*

months- Dr. Stites proposed as an amendment that the officers should serve for a period of one year- the amendment lost, and the motion as originally offered carried.

Upon the motion of Mr. Smith duly seconded by Mr. Brown the initiation fee was placed at \$1.00.

The members of this society held a special meeting ~~of the society~~ at the office of Mr. J. M. Stites on Monday the 21st day of April at 4 ~~o'clock~~<sup>P.M.</sup> for the purpose of hearing the report of the committee selected to choose a name and to recommend suitable by-laws for the society -

The secretary read the meeting minutes of the previous meeting and upon the motion of Mr. Bassett seconded by Mr Underwood they were approved ~~by~~ ~~the society.~~

The committee through its Chairman Mr Stites reported that they had selected the name of "The Athenaeum" as <sup>a suitable</sup> ~~the~~ name of the ~~society.~~

Upon the motion of Mr Brown seconded by Mr Smith the society ratified the action of the committee in the selection of the name "The Athenaeum."

The committee through its chairman then read the by-laws they had prepared and upon the motion of Mr J. C. Underwood seconded by Mr. Meacham the society considered each section separately and then as a whole. After discussing each section thoroughly and making several amendments to the by-laws as reported by the committee the following by-laws were passed each section separately and then as a whole.

### By-Laws.

§1. Name and Object. The name of this society shall be "The Athenaeum". It shall have for its object the increase of information among its members on subjects relating to literature, science and the arts.

§2. Officers. The officers of the society shall be a President, a Vice-President and a Secretary and Treasurer. They shall be elected

ted at the first regular meeting in April of each year, and shall serve for one year, and until their successors are elected.

§3. Committees. The President, Vice-President and Secretary Treasurer shall constitute the program committee. It shall be the duty of this Committee to prepare, and announce at each meeting of this Society, a suitable program for the next regular meeting.

§4. Duties of Members. (a) It shall be the duty of any member of this Society, when called upon for service by the Committee on Program to respond promptly, and this committee shall take in writing and report to the next meeting of this Society any excuse which may be offered for failure to accept duty. And should any member, after acceptance of duty, fail to respond without excuse

therefor in writing, and accepted by the society, the name of such member shall after one month's notice be dropped from the roll of members.

(b) Attendance. At each meeting of the society the secretary shall call the roll of the members, and it shall be the duty of any member absenting himself to have presented a written explanation of his absence.

After two consecutive absences, unexcused by the society, the secretary shall notify in writing the member in question to appear before the society at its next regular meeting. If he fail then to appear his name shall be dropped from the roll of members.

§5. Application for Membership. Application for membership in this society shall be in writing

Signed by the applicant and endorsed in writing by not less than three of its members.

Such application shall lie over until the next regular meeting of the society, when it shall be voted on, three adverse votes being sufficient to exclude from membership, the voting being by secret ballot.

§6. Fees. An initiation fee of \$1.00 shall be paid by each member of this society. And the dues of the society shall be 50¢ monthly, payable in advance.

§7. Records. It shall be the duty of the secretary to keep a correct roll of the membership of this society. All records of the society shall be kept by the secretary in a book set aside for that purpose.

§8. Quorum. Eight members and one officer

present together, shall constitute a quorum.

89. Amendments. These by-laws shall not at any time be suspended. Any amendment to same shall be allowed only with the consent of two thirds of the entire membership, and after one months notice.

Each member shall sign the by-laws and agree to abide by same.
