ATHENAEUM'S EATLESS BANQUET.

Patriotic Gathering of Literary Lights with Many Happy Guests Listen to Dinnerless Orators.

"The Athenaeum, Hopkinsville's literary soceity for men, one of the leading organizations of its kind in Kentucky, held its fifteenth annual "banquet" last night at Hotel Latham. The society is 17 years old but had no banquets the first two years. The membership is limited to 30 and the May meeting is always an open session with speeches instead of papers and usually an elegant meal is spread for a maximum of 120 persons, each member being entitled to four seats. This time by a patriotic impulse the members voted to have no "eats" but to pay \$1 for a minimum of 60 tickets and after defraying necessary expenses donate the balance to the Red Cross. Considerably more than 60 were present last night, many of the members availing themselves of the privilege of inviting three guests.

"The members and guests assembled at 8 o'clock in the parlors of Hotel Latham and at 9 o'clock descended to the dining room where the speakers were provided with a table and the members and visitors were arranged in seats around the room.
