30TH ANNIVERSARY OBSERVED BY CLUB

Banquet Held Last Night At Latham; W. B. Holmes Presided At Meeting

The 29th annual open session of the Athenaeum, held at Hotel Latham Thursday night, May 12th, closed the thirtieth year of the society. was organized April 21, 1902 with 16 charter members. The open sessions were begun in 1904 and have been held every year since that time. During the war year of 1918, the open meeting was an "eatless banquet," no food being served. Sumptuous banquets have characterized all other open sessions, to which each member was privileged to invite three guests. The membership of the society is limited to 30 and the present number is 29. This made possible the presence of 116 members and guests and including the boys and girls who made up the High School orchestra the full limit was in attendance for the first time in the long series of open sessions. closely approached.

Four of the charter members were present. In many respects the entertainment was the most successful ever held by the society. A bright, beautiful "blackberry winter" day and evening made the weather ideal and the menu provided was all that could have been

desired.

The arrangement of tables was a departure from the usual long tables. There were 16 tables scattered about the large dining room, seating from four to 18 persons each. The president and all of the speakers, with their guests, were seated at the largest table on the south side of the room. The orchestra of 16 pieces was located in the northeast corner and rendered delightful selections during the meal.

The party assembled in the parlors at 7:30 and the program moved with clock-like precision. The reception committee, composed of the President and Vice-President, together with the speakers, and their wives, formally welcomed the guests and at five minutes to eight the start was made for the dining room.

The tables were all beautifully decorated with flowers, this work having been done under the super-

vision of a committee of ladies headed by Mrs. Phil Chappell.

The invocation was pronounced by the Rev. David M. Walker, and the dinner was promptly served,

President Holmes was the first speaker, welcoming the guests and addressing himself to the subject of "Desultory Remarks" assigned him, indulged in flights of eloquence, told jokes at the expense of some of the members and concluded his brief speech by introduc-

ng as the next speaker John Stites, one of the organizers of 30 years ago. Mr. Stites discussed the subject of Tramps from all angles, even drawing upon the Scriptures for some of his proof, that they were not unknown in the earliest ages. Apologizing for the political color of his speech, he discussed Cleveland's army of 600 under Gen. Jacob S. Coxey and the present army of 6,000,000 unemployed under Hoover. His address was replete with historical information of famous heretics of past ages who had changed the

currents of human affairs by exploring unknown fields out of regular channels of science and discovery as well as religion.

It was replete with instructive information and scientific knowl-

edge.

At the conclusion of Dr. Powell's discourse, President Holmes announced that Mr. Clark would be given another chance. He got off better the second time and was finally stopped without having to call in the police. He took a crack at pretty much everything from Eve's costume of leaves to the absence of foliage in the city parks. At times the ladies blushed, but he was allowed to proceed as his "lapse of memory' had put the hearers in a sympathetic mood. He closed with a flight of eloquence that made them forget some of the other things he had said.

The last speaker of the evening was James Breathitt, who told what he knew about "Birds of a Feather." It turned out that he knew a good deal and he told it well, with all the grace and charm of the finished orator he is. His tribute to the American eagle and his toast to the ladies, even rivaled some of the eloquent flights of the toastmaster. He concluded as the city clock struck eleven and the hilarity ended, with all rising and singing "My Old Kentucky Home."
