There being no further business the secretary was requested to call the evening's program.


Chas. Steele presented a paper entitled, "Some aspects of Man Striving To Maintain Human Behavior".



The membership Committee recommended William P. Munday and Leslie Crane for membership, to be voted upon at the October meeting.


There being no further business to come before the Society the Secretary was instructed to call the Program:

W.E. Rogers was excused from attendance until January because of teaching duties.


There being no further business the secretary was requested to call the program for the evening:

"Pretrial In The News Media".


