Robert M. Fairleigh presented a paper entitled;

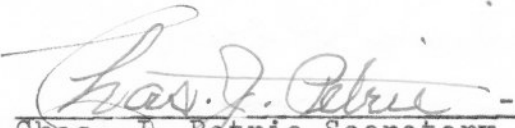
"Commodity Or Money"

George M. Draper presented a paper entitled; "Human Mathematics"

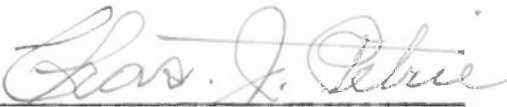
James M. Wooldridge presented a paper entitled;

William Edmunds presented a paper entitled;

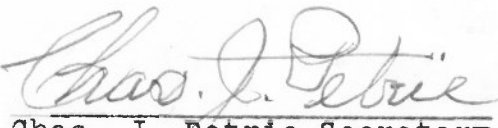
"Stonshenge"
