Guidelines for Honorary Membership in the Athenaeum Society

It is the constitutional prerogative of the Society to bestuw Honorary Membership status by a majority vote at any regular meeting. The following Guidelines are recommended in the interest of fairness and consistency:

1. Active Members.

- a. The request of the member, and
- b. Evidence of a long-term physical condition (other than volitional priority) making it impossible to fulfill regularly the responsible lities of active membership.
- c. This status is available only to those active members for whom a Leave of Absence status is inappropriate.
- 2. Non-Members.
  - a. Election by the same process used for choosing Active Members.

Dr. Thomas L. Riley presented an anecdotal biography concerning -


The Life and Times of Asbury Harpending, a native son of Caldwell County and pioneer, prospector and developer of the California - Nevada Area.
