The January 5, 2006 meeting of the Athenaeum Society convened at 6:35 P.M. at the Holiday Inn. An opening prayer was given by Brooks Major.

Following dinner of salad, mashed potatoes, brussel sprouts, corn, black eyed peas, fried chicken, roast beef, rolls, corn bread and cherry cobbler, President George Byars called the meeting to order at 7:10 P.M.

Mr. Cayce described in words and photographs, the daily activities, meals, artifacts and the joys of being part of an archeological dig in an area so rich in Biblical history. (7:20 - 7:42 P.M.)

Dr. Freer's paper was titled "On But Not Over The Hill". The presenter gave his paper as a tribute to Louise Hightower Holloway, an LPN at Western State Hospital from 1936 through 1978. The paper is a history of the Western State Hospital from its beginning as Western Lunatic Asylum in 1854 on 386 acres of the former Spring Hill Farm. The paper also describes various restraint and medication treatments used over time at the hospital. The membership was electrified to learn that electric shock treatment is still used at some treatment facilities in the country, although not at Western State Hospital. (7:43 - 8:15 P.M.)

The comment session began at 8:25 P.M., hearing from members Turner, Adams, R. Guffey, Sivley, Byars, and Rowlett. Rebuttals followed.

The February 2, 2006 meeting of the Athenaeum Society convened at 6:32 P.M. at the Holiday Inn. An opening prayer was given by William Rowlett.

Following dinner of salad, mashed potatoes, pinto beans, green beans, yams, Salisbury steak, baked chicken, rolls, corn bread and peach cobbler, President George Byars called the meeting to order at 7:05 P.M.

The Secretary, Bob Cope, called the roll which indicated that 32 of 40 members were present. Minutes of the January 5, 2006 meeting were read and approved. Excuses of past absences were presented and accepted.



The March 2, 2006 meeting of the Athenaeum Society convened at 6:30 P.M. at the Holiday Inn. An opening prayer was given by Brooks Major.

Following dinner of salad, mashed potatoes, green beans, squash, spinach, macaroni & cheese, fried chicken, pork chops, roast beef, rolls, and assorted deserts, President George Byars called the meeting to order at 7:05 P.M.

The Secretary, Bob Cope, called the roll which indicated that 34 of 40 members were present. Minutes of the February 2, 2006 meeting were read and approved. Excuses of past absences were presented and accepted.

April 6, 2006

The April 6, 2006 meeting of the Athenaeum Society convened at 6:40 P.M. at the Holiday Inn. An opening prayer was given by William Rowlett.

Following dinner of salad, brussel sprouts, mashed potatoes, black-eyed peas, corn, ham with pineapple, fried chicken, rolls and peach cobbler, President George Byars called the meeting to order at 7:07 P.M. Curtis Brasher, honorary member of the Society, was welcomed to the meeting.

The Secretary, Bob Cope, called the roll which indicated that 24 of 40 members were present. Minutes of the March 2, 2006 meeting were read and approved. Excuses of past absences were presented and accepted.

The Treasurers report was given by Bob Cope indicating that \$3,069.68 was in the bank account.

Bob Cope advised that Meeting Site Committee (William Turner, Frank Nash, Wynn Radford) had decided that the location of the May 4 Open Meeting would be the Holiday Inn. On a motion by John Freer, second by Jim Love, the membership voted in favor of the Society subsidizing \$10.00 per person of the total cost of the Open Meeting, resulting in a cost of \$25.00 each.

At the request of Terry Fuqua, George Byars appointed Marvin Denison and Mitch Kaye to look into the cost of purchasing a PowerPoint System for the Society and report back at the September meeting.

Bob Sivley reported for the Nominating Committee (Sivley, Macdonald and Denison), recommending D. D. Cayce, III for 2006 -2007 President, Logan B. Askew for Vice-President and Robert Cope for Secretary-Treasury. Motion by Hal King, seconded by Peter Nicolos, motion passed.

Papers were presented by Robert E. Ison member since 2000 and number 26 in seniority and Robert B. Sivley member since 1970 and number 4 in seniority.

Mr. Ison's paper was titled "Lincoln, Great Emancipator of Simply Great Politician". The paper is a study of Lincoln's dislike of slavery and how he used his political power and wisdom to effect change in the Constitution. The paradox and question that presents itself is, "if he hated slavery so much, why did Lincoln not become an abolitionist?" Although he is known as the "great emancipator", Lincoln was keenly aware that slavery, though wrong in his eyes, was sanctioned by law and he frequently acknowledged that the rights of slave owners, both to retain slaves and to have slaves returned, were guaranteed in the Constitution. The presenter's view is that Lincoln was simply a great politician who used

emancipation as another tool to restore the union. He used his "was powers" to effect change in an area he was otherwise powerless to act. He did not actively campaign for a constitutional amendment to end slavery, because it would not have been politically expedient. (7:31 - 8:00 P.M.)

Dr. Sivley's paper was titled "The Trial Of The Century". The paper describes the famous "Scopes Monkey Trial" which took place in the summer of 1925 in the little town of Dayton, Tennessee, 40 miles northeast of Chattanooga. The charge - violating a Tennessee law that forbade the teaching of evolution in the public schools. The trial pitted William Jennings Bryan for the prosecution against Clarence Darrow for the defense. While the ACLU was providing financial support for any teacher who was arrested for violating the law, some of Dayton's city fathers, including the Mayor and School Superintendent, thought of a scheme that might attract national attention to their little town and be good for business. John T. Scopes became the pawn of unscrupulous civic leaders and was persuaded to be the catalyst for the "big event" even though he had only substituted as a biology teacher and had never taught evolution. The outcome of the so-called monkey trial was anticlimactic and although he never took the stand, Scopes was found guilty and fined \$100. Dayton city fathers may not have achieved their goal to put Dayton on the map for it was forever to be referred to as "the little town in Tennessee where they had the monkey trial" and is not much bigger now than it was then. (8:02 - 8:25 P.M.)

The comment session began at 8:35 P.M., hearing from Misters Kasiarski, J. Tilley, Dennison, R. Guffey, Rowlett, Fuqua, Lynch, Love, D. Guffey and Askew. Rebuttals followed.

The presenters for the May 4, 2006 Open Meeting were announced as William T. Turner and Mark G. Schweizer.

The May 4, 2006 open meeting of the Athenaeum Society convened at 6:35 P.M. at the Holiday Inn. An opening prayer was given by William J. Watson, III. President George Byars welcomed all members and guests to the Annual Open Meeting.

Following dinner of Prime Rib with Carver, Shrimp Kabobs, Turkey & Dressing with Gravy & Cranberry Sauce, Twice Baked Potatoes, Capri Blend Vegetables, Whole Kernel Corn, Whole Baked Apples, Salad, Rolls, Assorted Gourmet Desserts, Water, Coffee and Tea, George Byars called the meeting to order at 7:20 P.M.

Following dinner of salad, lasagna, chicken, liver and onions, brussel sprouts, green beans, baked beans, mashed potatoes, rolls, cherry pie and peach cobbler, President D. D. Cayce, III called the meeting to order at 7:07 P.M.

The Secretary, Bob Cope, called the roll which indicated that 27 of 39 members were present. Minutes of the May 4, 2006 Open Meeting were read and approved. (Motion by Adams, Harper second) Excuses of past absences were presented and accepted.

The Treasurers report was given by Bob Cope indicating that \$1,646.94 was in the bank account at the end of the 2005-2006 meeting year.



A brief biography of each of the Brakefield Boys was presented, including the presenter, who is one of three surviving team mates. Coach Brakefield went on to a successful coaching career as various colleges, including Appalachian State University in Boone, North Carolina where his 1970 team posted an 11-1 record and a 20 game winning streak. The Treasurers report was given by Bob Cope indicating that \$2,866.47 was in the bank account.

The Membership Committee report was given by Charles Tilley. The name of Austin Moss was submitted for consideration. Mr. Moss was elected into the membership by secret ballot bringing the membership to 40. The Secretary was directed to write Mr. Moss informing him of his new member status.

Papers were presented by George H. Byars, member since 1987 and number 19 in seniority and Robert Y. Harper, member since 2000 and number 27 in seniority.

Mr. Byars' paper was titled "The Great American Work Ethic". The paper attempts to define what we call work ethic. The presenter, a self proclaimed "slacker" since his retirement, comes to the conclusion that Sigmond Freud came as close to anyone in 1930 when he stated that "The work ethic, finally has little to do with reality. It's simply an attitude or feeling about how we and others spend our days the way we do. It all depends on who is looking at whom at what moment." So, in the words of the presenter, "hard work has a future, laziness pays off now." (7:18 - 7:44 P.M.)

Mr. Harper's paper was titled "TRAMPing Through History - The life of Theodore Roosevelt Augustus Major Poston, Part 2". The presenter picks up on his "maiden voyage" paper describing the life of Mr. Poston, born and raised in Hopkinsville, who wrote a series of short stories published posthumously as "The Dark Side of Hopkinsville." The current paper covers the period of Mr. Poston's life from his return to New York in 1932 from the Soviet Union until the Brown verses Board of Education case in 1954, which led to the desegregation of public schools. As a black journalist, Ted Poston was ahead of his time, challenging the established protocol for the benefit of mankind and the profession. (7:45 - 8:24 P.M.)

The comment session began at 8:30 P.M., hearing from Mistery Sivley, Denison, Adams, Freer, Love, David Cavanah, King, White and Radford. Rebuttals followed.

The presenters for the January 4, 2007 meeting were announced as Dr. William M. Rowlett and Mr. Charles R. Guffey.

The meeting adjourned at 8:58 P.M.
